

- Assessment completed with individual to determine what barriers they have to returning to the community.
- Common barriers include: need for independent housing, need for placement in more supportive setting, need for ramps, need for care at home.
- Referrals made on their behalf to meet those needs.
- Transition program has funds available to address certain barriers

TIMEFRAMES:

- MAKE A REFERRAL AS SOON AS THERE IS A NEED IDENTIFIED OR EVEN IF THERE IS JUST UNCERTAINTY.
- HAVE TWO WEEKS TO ASSESS.
- DOES TAKE TIME TO IDENTIFY SERVICES AND ARRANGE FOR CARE IN THE COMMUNITY.
- HOUSING OFTEN HAS WAITLISTS AND IT CAN BE DIFFICULT TO OBTAIN DOCUMENTS TO START APPLICATION PROCESS.


- Follow along and support
- Transition Navigator remains involved throughout the process
- Collaborates with informal supports and nursing home staff
- Assists with discharge planning and ensuring that the plan is followed through on
- Continued involvement for 30 days post discharge
- Individuals might have other supportive programs in place post discharge that would be ongoing.

One-time visit to discuss resources in the community

Must:

- Be living in a nursing facility
- Express a desire to explore options

MI Choice Medicaid Waiver

Is a Medicaid-funded long-term care program to help individuals live in the most independent setting possible (independent home or assisted living)



Qualifications:

- 18-64 years old with certified disability or 65+
- Eligible for long-term care Medicaid
- Monthly income below \$2,382 (gross amount)
- Meets nursing home level of care criteria
- Has ongoing need for services

Purchase of Service Agreements

Eligibility Requirement

- Kent County resident and 60 years of age or older
- Donations accepted and some cost sharing is required

History of the KCSM

- Voters approved a renewal and an increase in August 2014
- Services originally started in 1999
- Current 8 year millage 1/2 of a mill for 2015-2022

Additional Support

- KCSM partners have worked to provide additional support to seniors and their caregivers during the coronavirus pandemic
- This has included the delivery of essential items and wellness check phone calls



Older Americans Act

- Funding comes primarily from the Federal Older Americans Act and the State Older Michiganians Act.
- In FY 21 (October 1, 2020 through September 30, 2021) we have full contracts with 29 service partners throughout the nine-county region
- We awarded \$7,522,248 to provide services such as: Adult Day Care, Caregiver Support programs, Home Delivered Meals, Homemaker, Outreach & Assistance and Transportation.

How to report suspected abuse and neglect:

- A few Warning Signs to look out for:
- Unexplained or frequent bruises or injuries
- Torn or dirty clothing
- Not socializing or the caregiver won't allow family or friends to visit
- Sudden changes in banking or spending patterns

If you suspect abuse or neglect, call APS. If abuse is taking place in a licensed long-term care facility, be sure to call the Michigan Long-Term Care Ombudsman.



Caregiver Resource Network



The Caregiver Resource Network (CRN) is a collaboration of more than 100 organizations. The CRN recognizes that family caregivers provide the majority of care that helps family members stay in their own homes. The goal of the CRN is to help family caregivers by providing education, services and resources to help them along their journey. The CRN meets on a bi-monthly basis. Our meeting time allows for professionals to network, have an education opportunity, and share about their upcoming activities.

Family Caregiver University (FCU) is a once a month educational class for family caregivers. Topics covered in the Family Caregiver Classes are broad, and cover many issues that the caregivers are facing. Many of the presenters for the Family Caregiver University Classes are members of the Caregiver Resource Network.

Diversity Academy programs happen 2-4 times a year. Topics for classes are based upon interest from the community. Some of the topics that have been tackled in the past include: "Caring for Veterans", "Caring for the LGBTQ community." The CRN Continues to offer these classes in order to best serve the diverse population of clients in our area.
