LOCAL SENIOR ADVOCATE GROUP GIVES VOICE TO OLDER ADULTS

THE WHY

The Advocates for Senior Issues (AFSI) has a reputation as the premier older adult advocacy group in the state. The AFSI is a non-partisan group that strives to be inclusive of all of Kent County's diverse senior communities.

THE WHO

Some of our 300+ members represent retiree groups, senior centers, or retirement communities, bringing the estimated reach of the group to over 10,000. AFSI members have various backgrounds, affiliations, and work histories, but many have a history of services, volunteerism, and/or activism.

THE IMPACT

In addition to learning how to advocate, members are educated on topics of importance to seniors. Programs include elder abuse and scams, healthy aging programs, senior driving issues, aging in place, Medicare Part D, and much more. State Senators and Representatives, as well as local County Commissioners and other special guests, are also invited to address the group.

THE HISTORY

The group started meeting in 1982 under the name Senior Citizen Senate. Founded and led by Sister Agnes Theil, they originally started with just a few dozen members. In 2001 the group officially changed its name to "Advocates for Senior Issues". The group was instrumental in bringing the Medicaid Waiver program to Kent County in 1992, making it one of the first counties in the state to have this cost-efficient program. They also played a major role in the Kent County Senior Millage campaign in 1998, and the renewal and increase in 2006 and 2014.

THE LEGACY

Two members earned the Blue Cross/Blue Shield Claude Pepper award for advocacy. Three members of Advocates for Senior Issues have received the Governor's statewide Senior Leadership Award, and five members from the group have been awarded a Medal of Merit by former U.S. Congressman Vern Ehlers. Three members have received the Maggie Fegel Award.

THE ACTION

General membership meetings are held monthly, with the exception of July, August, and December. Membership meetings take place on the third Friday of the month, 10 am-12 pm, with an average attendance of 125 members. Visitors are welcome and encouraged to attend a meeting to see the organization in action.
