QUARTERLY PROGRAM HIGHLIGHTS OF THE KENT COUNTY SENIOR MILLAGI

Kent County Senior Millage

The Kent County Senior Millage (KCSM) provides support and services that help Kent County seniors live in their own homes for as long as possible.

Each year the KCSM holds an open proposal process. Proposals are reviewed by the Millage Review Committee, which is a group made up of Kent County Commissioners and Kent County residents. Agencies whose proposals are approved then make a presentation to the committee in the fall.

Funding recommendations for KCSM Services are determined by the Millage Review Committee and approved by the Kent County Board of Commissioners.

Funding for the services comes from taxes paid by Kent County homeowners. For 2019, the committee and the Commissioners approved \$11,078,000 in funding to contract 32 agencies for 53 unique services. One new service added in 2019 is *Gently-Used Mobility Equipment*, a service provided by Alternatives in Motion.

Alternatives in Motion

Alternatives in Motion provides gently-used mobility equipment - a new service available this year through KCSM. Coleen Marie Davis, Executive Director of Alternatives in Motion describes, "For people with disabilities, mobility offers a sense of freedom: freedom to

plan, freedom to achieve, freedom to dream."

Alternatives in Motion will also deliver the equipment with their "community van," so seniors won't have to be concerned about finding a way to pick it up.

Davis says the funding

they've received through KCSM will "help us keep up with the 203% increase in clients we have served in the past two years."


To receive equipment through Alternatives in Motion a one-page application needs to be completed to determine eligibility, along with a signed waiver.



It is important to be aware that there is a \$10.00 cost share per piece of equipment. Contact Alternatives in Motion to learn more about receiving gently-used mobility equipment.

Recreation Therapy Program

The Stepping Stones Program through Life Therapeutic Solutions has been providing Recreation Therapy to older adults for the past 20 years. Kristine Schwab, Owner of Life Therapeutic Solutions and Certified Recreational Therapist states, "We decrease



social isolation and increase an individual's independence." Stepping Stones works one to one with individuals who have social, emotional, cognitive and physical disabilities.



Because Recreation

by insurance except auto
no-fault, Schwab says,
"The millage has helped
us provide this essential
service to older adults in
our community regardless
of their ability to pay.

Anyone can make a referral to the Stepping Stones program: an individual, family member, church or facility. A therapist will perform an inhome assessment and discuss treatment goals. Use the contact information below to get started.

Kent County Community Action

Kent County Community Action (KCCA) offers several KCSM funded services to older adults in Kent County. All services are provided in English and Spanish.



KCCA provides Outreach and Assistance to those seeking services. As a partner of RideLink, they offer transportation

services. KCCA also helps homeowners and renters with their Weatherization program by providing methods to increase energy efficiency. Last, their Meal program offers congregate and home delivered meals, featuring

Latin American cuisine.

Millage Service Eligibility for 2019

Senior Millage services are available to Kent County residents, age 60+. Cost share/copayment may be required for individuals whose incomes are above \$24,980 and couples with incomes above \$33,820 for 2019. Cost share fees are based on income and assets. Fees may vary depending on the service type. For more information, contact the organization providing services.
